10. Footpaths and Highways:

- 10.1** Cllr S Avery reported that we were still waiting for the gullies to be cleared. Cllr A Dewhirst replied that he had met with Highways and all gullies on the list were scheduled for intervention work (rather than just a standard clean) during which they will check that the whole system is working correctly. He also reported that blocked gullies and drains can now be reported on the 'Report a Problem' page of the DCC website.

12. Parish Matters:

12.3 Subject to future guidelines for holding public meetings, it was agreed that in the coming months, the parish council would start working towards drafting the CIL Community Consultation.
12.4 As with item 12.3 the council to start working towards the Neighbourhood Plan Consultation.
12.5 It was agreed for Cllr A Parkes to draft an Emergency Plan.
12.6 It was agreed that Cllr A Parkes and the Clerk would draft an agreement for implementing the Strategic Plan's action plan.
12.7 There was no update on the parish council's request to TDC to increase councillor numbers.
12.8 There was no update on the date for the parish council's new website to go live.
